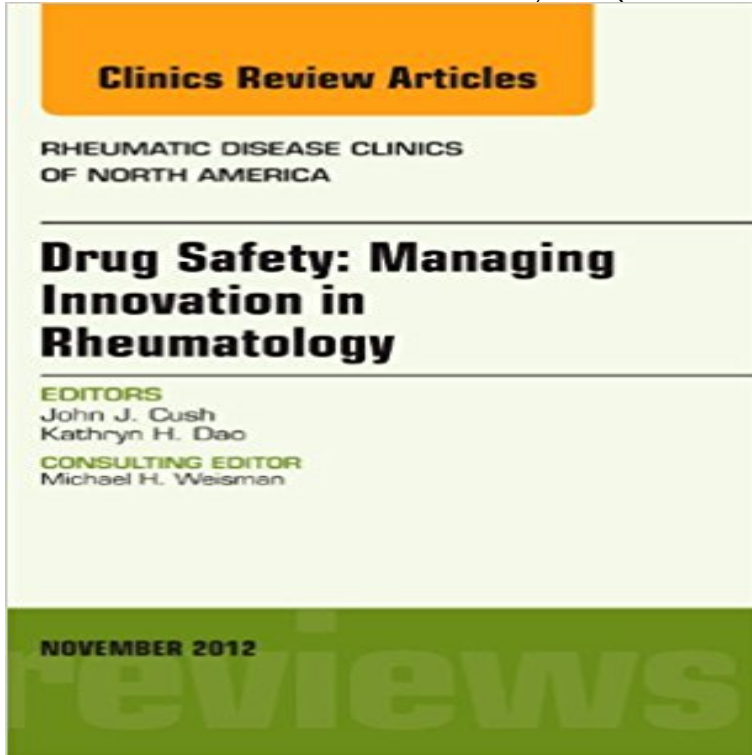


Drug Safety: Managing Innovation in Rheumatology, An Issue of Rheumatic Disease Clinics, 1e (The Clinics: Internal Medicine)
